# Protecting Black Communities From Racism

We will be a peaceful, Black-led municipality dedicated to protecting life, liberty, and community unity.

We'll believe in the lawful right to defend ourselves against violence, terrorism, and racially motivated attacks.

Our priority will be to preserve life, maintain peace, and ensure justice for all residents.

## Purpose

**This policy establishes clear guidelines for the justified use of deadly force by community peace officers and authorized members during immediate threats to life and safety, particularly in response to racially motivated violence or terrorist acts against our future communities.**



# Principles in Our Future Municipal Incorporations

## No Overkill or Retaliation:

Once a threat is neutralized (disarmed, incapacitated, or no longer a danger), deadly force must cease immediately.

We reject unnecessary violence, abuse, or vengeance.



## Defense of Community:

Acts of terrorism, arson, mass violence, or attempted murder against our residents constitute deadly threats and may be lawfully met with immediate, proportional deadly force.

# Principles in Our Future Municipal Incorporations

## Preservation of Life:

Deadly force may only be used when absolutely necessary to stop an imminent threat of death or serious bodily injury to future residents or officers.



## Protection Against Infiltration and Racial Terrorism:

Racists or racial terrorists attempting to infiltrate or harm the community are considered hostile threats once they engage in violent action.

Peaceful speech, even hateful speech, alone is not grounds for deadly force unless accompanied by immediate deadly action.

# Authorized Use of Deadly Force in Future Municipals

Deadly force will be authorized under the following conditions:



The attacker presents an immediate threat of death or serious bodily harm to any resident, officer, or visitor.

The attacker is engaging in acts intended to cause mass death or destruction, including arson attacks on occupied buildings, shootings, bomb threats, or similar violent actions.

There is no safe alternative to prevent death or serious injury.

The force used is proportional to the threat and stops once the threat is neutralized.

## Immediate Notification:

Contact emergency services (911) and report the incident immediately.

## Medical Aid:

If safe to do so, provide medical assistance to any injured persons after the scene is secure.

## Documentation and Evidence Preservation:

**Officers and authorized members will have to complete an incident report within 24 hours.**

**All body camera, surveillance, and witness evidence must be preserved and submitted for review.**

## External Reporting:

**Deadly force incidents will be reviewed by an independent legal authority (municipal prosecutor, state agency) to ensure full transparency and compliance with the law.**


